
An Overview of St. Martin Parish Corrections Facility












Facility Overview

The St. Martin Parish Corrections Facility operates under the leadership of Sheriff Becket Breaux, managing various divisions to ensure operational efficiency and inmate care.

Location

Located at 400 Saint Martin Street, St. Martinville, LA, the facility serves the local community while maintaining secure operations. Its mailing address is P.O. Box 247, St. Martinville, LA 70582, ensuring residents can contact the facility easily.





Leadership

Sheriff Becket Breaux oversees the St. Martin Parish Corrections Facility, ensuring adherence to laws and regulations. His leadership influences operational strategies, inmate management, and community relations.

Key Divisions

The facility consists of the Main Jail, Work Release Program, Patrol, and Investigations divisions. Each division serves a distinct purpose, contributing to the overall functionality of the corrections system.

Inmate Mortality Data

Inmate mortality data reveals significant incidents that highlight challenges in facility operations and transparency.


Incident Reports (2019)

In June 2019, a male inmate was found unresponsive in his bunk and later pronounced dead at a hospital. This incident was investigated by the Coroner's Office and the U.S. Marshal's Office, but the cause of death was not disclosed publicly.



Incident Reports (2022)

On September 22, 2022, Holly Granger, aged 31, was found unresponsive in her cell and was declared dead despite lifesaving efforts. The Lafayette Parish Sheriff's Office ruled her death as an apparent suicide, indicating no foul play was suspected.



Incident Reports (2024)

On July 11, 2024, Alvin Pete, age 61, experienced a medical emergency and was pronounced dead after being transported to a hospital. The cause of death is currently pending autopsy results, raising questions about the facility's medical response capabilities.

Investigative Follow-ups

The three incidents of inmate deaths raised significant concerns about the facility's reporting practices and the adequacy of investigations. Additionally, these deaths do not appear to be properly logged in the shared Google Drive spreadsheet nor the corroborating official forms logged.



Revealing Data Discrepancies in Incarceration Reporting

Analyzing the Zero Death Letter and transparency issues reveals significant gaps in the reporting of inmate mortality at St. Martin Parish Corrections Facility.

Zero Death Letter (ZDL)

The facility issued a Zero Death Letter for October 1, 2022, to September 9, 2023, confirming no deaths occurred during that timeline. However, this report does not include documented deaths from 2019, 2022, and 2024, raising concerns about the comprehensiveness of the data provided.




Transparency Issues

Public records indicate missing information regarding notable inmate deaths, suggesting gaps in the facility's reporting practices. These transparency issues can undermine the public's trust and raise questions about accountability in the facility's operational procedures.

Public Records Gaps

The discrepancies in reporting reflect a broader concern about public access to accurate and timely information. By not acknowledging historical deaths, the facility risks creating a perception of negligence and a lack of commitment to accountability in adverse incidents.



Recommendations for St. Martin Parish Corrections Facility

Addressing key areas of improvement can enhance transparency, accountability, and compliance within the facility.



Clarify Reporting Scope

The facility must define the timeframes for the Zero Death Letter (ZDL) to ensure all deaths are accounted for, including those outside reporting periods. This clarity will enhance public trust and facilitate accurate statistical reporting.

Acknowledge Historical Deaths

The facility must recognize and confirm the submission of forms related to the deaths of inmates in 2019, 2022, and 2024. This acknowledgment will address previous transparency gaps in reporting and ensure compliance with relevant regulations.






Improve Records Processes

Public records processes must conform to Federal & Louisiana law (e.g., § 44:1 et seq.) to facilitate timely responses. Streamlining and automating public reporting processes will enhance accessibility and ensure compliance with legal standards for public records requests.

Integrate Class Resources

Logging all deaths and related changes in a shared spreadsheet is essential for public interest and legal analysis. This integration will provide a centralized location for information and enhance transparency as findings are made available.



Foster Accountability

The facility must ensure compliance with federal mandates and Louisiana Department of Public Safety requirements. By cross-checking facility submissions with state and federal reporting obligations, accountability can be significantly improved.
